# Understanding the impact of The Fostering Stable Housing **Opportunities Act (FSHO) on Child Welfare Practice**

Since the early 80s state and county Independent Living Supervisors, have offered an increasingly sophisticated array of self-sufficiency services to prepare foster youth for adulthood. In 2007, Congress codified this practice in law requiring child welfare agencies to offer independent living services to youth who reach age 14 in state care.

As a result, many youth go on to college, the military, find gainful employment, and take a variety of other paths. Despite progress in child welfare practice, housing options for youth who are at risk of homelessness have continued to be elusive and offered in a frustratingly unpredictable manner. As a result, more than a quarter of the 20,000 youth who age out experience homelessness.

In 2016, a group of foster youth and alumni led by ACTION Ohio took it upon themselves to eliminate this uncertainty by synchronizing HUD's Family Unification Program (FUP) with emancipation - and eliminating geographic disparities in the Program. Together with

Reps. Turner, Bass, Dean, and Waters and Sens. Brown, Grassley, and Crapo they wrote a bill which became law on December 27, 2020, The Fostering Stable Housing Opportunities Act (FSHO).

FSHO codifies a universal, on "on demand" distribution mechanism for HUD's Family Unification Program. This means that FUP requests can be poperly synchronized with emancipation from foster care for youth at risk of homelessness. HUD Sec. Carson used his regulatory authority to begin distributing vouchers in this manner through the Foster Youth to Independence (FYI) Initative in 2019. In less than two years, FYI has helped 1,000 youth move into their own apartments.

FSHO also helps youth build assets and rewards youth for working by offering them access to HUD's longstanding Family Self-Sufficiency Program (FSS). If youth voluntarily enroll in FSS or a similar program, they can earn an additional two years of rental assistance. Read how FSHO ends homelessness here.

Betsy immediately assembled a National Committee on Early Childhood and Family Housing Policy. Betsy has spent over 25 years helping families access permanent housing as well as developing the systems-level partnerships necessary to increase access to housing choice vouchers and services to keep families together and safe.
